I have continued to work occasionally for Economica Ltd. while teaching full-time.

Consultant, Economica Ltd. 1995-2003 Economica Ltd. is a consulting firm specialising in the provision of litigation support in personal injury and fatal accident cases. I have prepared over 500 personal injury and fatal accident reports. This involved reviewing tax returns and financial statements, estimating the likely income path of the injured party, and performing present value calculations. In addition the position involved the interpretation of Census data and many other forms of statistical information. I have contributed to the company's production of productivity growth, inflation and real interest rate forecasts, and have testified in the Alberta Court of Queen's Bench.

While most of these deal with narrow issues of importance only to the assessment of injury losses, a few have more general interest. I would suggest Boston v.
